Successful Fall Season:

We have had a successful fall season, and now entering our Winter months. This nice weather
has continued to keep the pool extremely busy, with full classes, busy lap swim, and full
programming.

Staffing Success:

 Simpkins has had the most successful year of hiring since COVID. Summer months brought in the on the highest number of staff in years. We have continued with hiring and as of July hired 5 new Lifeguards and 4 new Head Lifeguards

Lifeguarding and CPR Training:

• Over the past three months, 7 lifeguarding, CPR, and Title 22 courses were held with a total of 80 participants. Offering these classes year-round has been vital for staff recruitment and retention.

New Noodle Ball Program:

• We started a new program this fall called Noodle Ball. This program is designed to teach kids the fundamentals of water polo with the help of pool noodle. The first session was a huge success with 15 enrolled participants with 6 on a waitlist. For the second session we added an instructor, so we were able to add 8 more participants to the program. Positive feedback has led to plans for the program to continue in the spring, potentially growing into a water polo scrimmage team.

Swim Lessons:

 Year-round swim lessons continue to thrive, with 251 participants since August. We are so happy to continue these lessons throughout the Fall and Winter months.

Private Swim Lesson Contractor:

A new private swim lesson contractor was brought on in October, with availability through December 21st. The contractor is currently 77% booked, with only 23 open spots remaining. The other two long-time contractors are fully booked, and 98 families have secured ongoing lessons. While our other two

long-time contractors are fully booked. A total of 98 families have been able to book on-going lessons with our 3 contractors.

Adult Programming:

• All of our programming that we offer to adults such as Adult Fitness, Water Aerobics, and Water Polo have had very high attendance.

Operational Schedule:

• The pool remains open seven days a week with extended hours: Monday through Friday from 6:00 am to 7:30 pm, and weekends from 9:00 am to 4:00 pm, ensuring accessibility for all community members.

Coastal Rail Trail

<u>Segments 10 and 11</u>: The project was awarded an allocation of grant funding for final design and right-of-way phases at the October California Transportation Commission meeting. Staff from the County, RTC, and City of Santa Cruz are working together to seek additional grant funding and find ways to reduce project costs. Staff are also coordinating with the RTC's Zero Emission Passenger Rail and Trail (ZEPRT) project to reduce conflicts between the trail and passenger rail requirements. Staff are working to define a scope of work for final design and to begin negotiation of a contract amendment with the consultant team for final design.

Ecology Action is continuing to lead the non-infrastructure programming portion of the project, coordinating with 10 area schools on bicycle and pedestrian education classes, and the creation of a community incentive program that will target low-income monolingual Spanish speaking residents of Live Oak, Pleasure Point, and Capitola. Additional pedestrian and bicycle classes at area schools are scheduled for Fall 2024.

<u>Segments 8 and 9</u>: Staff are still working on finalizing the Cooperative Agreement with the RTC and City of Santa Cruz. Final design for this project will begin in Fall 2024.

Floral County Park Playground Renovation

Site work and drainage modifications have been completed, play structure and PIP have been installed. County Parks has completed an informal bidding process and selected a contractor for the landscape work which is expected to begin in November. The project is expected to be completed in Winter 2024.









Freedom Lake Restoration Plan

Freedom Lake, a cherished natural resource for both wildlife and the community, has faced challenges from invasive species that disrupt native habitats and diminish water quality. In a series of upcoming workday events, dedicated teams from Watsonville Wetlands Watch and the California Conservation Corps will work side by side to remove invasive trees and plants that are impairing native habitat and obstructing the open viewing and access routes of park users. Consistent with best practices for riparian habitat and vegetation management, willow trees will be pruned and limbed up to reduce hazards for park users and enhance lines of site and the feeling of openness to enhance park user safety. Following winter rains approximately 100 native understory plants and shrubs will be planted within the Acacia removal areas to increase diversity of native plants growing on site and improve the park user experience. A phase 2 for this project is expected to commence and be completed in late Spring 2025.





Greyhound Rock

The Board of Supervisors approved an MOU between the Parks Department and the California Department of Fish and Wildlife (CDFW) to outline the steps necessary for transfer of the property from CDFW to County Parks. In addition, County Parks was awarded a \$865,000 grant from the State Coastal Conservancy in September. The grant will fund the planning, environmental review, and preliminary design of an environmental education center and low-cost overnight accommodation project that has long been envisioned for the site. Consultant procurement is scheduled to begin in late 2024, with selection in early 2025.

Hidden Beach County Park

The civil engineer developed the site work (building foundation and concrete paving, utility connections, landscaping, and associated irrigation surrounding the restroom) plans and specs. The project was informally bid in October and three bids were received. The low bidder asked to be relieved of their bid due to a calculation error, and the remaining bids exceeded the engineer's estimate and the amount that could be awarded via informal bidding per the Public Contract Code. As a result, County Parks is in the process of re-bidding the project via the formal bidding process. The project will be advertised on November 20th after approval by the Board. Construction of the project will be delayed by several months and is expected to start in January 20th, 2025. The permanent, prefabricated, ADA-compliant double-unit restroom has been designed and built and is now scheduled to be delivered on-site on February 26th, 2025. The project is expected to be completed in late Spring 2025.

Moran Lake County Park

Staff are still working to finalize permitting of the emergency rock revetment to prevent the failure of the pathway and East Cliff Drive from the 2023-2024 storms. A contract has been negotiated with Graniterock, but FEMA has not yet issued a Notice of Obligation for the funding. Should advance funding of the project be approved by County leadership, work to complete permitting will begin later this month. After permits are secured, repair work will occur while the lagoon is in a breach state and water levels are below the elevation of the work area.

Monarch Butterfly Habitat Management Plan: Parks collected comments on the draft habitat management plan via email and from a public meeting in July. Comments centered on concern over the safety of the eucalyptus and requests for Parks to do more to mitigate risks of tree failure, as well as concerns over how tree removals or reductions would negatively impact monarch habitat. In response to these comments, and to help determine how tree height relates to wind break efficacy, a specialized wind study was added to the scope of the habitat management plan. Results of the wind study are expected in early 2025 and will provide data to help guide management of the existing trees in a manner that protects butterfly habitat while ensuring public safety.


Parks will be leading a community tree planting event of native White Alder and Monterey Cypress trees at Moran Lake on December 7th from 9am-12pm. The tree plantings are required mitigations for past removals or tree failures and will help enhance the existing windbreak and improve the riparian habitat of the lagoon eco Volunteers are welcome and encouraged.


North Coast Facilities and Management Plan

The first quarterly meeting of the Working Group was held on October 11th. The meeting was well attended by agency representatives. Agencies shared updates on projects included in the Plan, as well as highlighted several new projects which were not included in the Plan but are important for interagency coordination and collaboration. The next meeting of the Working Group will be held in January. Discussion topics will include the creation of a public-facing North Coast website, and the County hosting a GIS Webmap that will serve as a repository for North Coast projects and public facilities. Pace Property Connection Trails

Project trail layout and flagging have been completed with great interest from the community. Park staff have coordinated directly with the biologist and trail design consultant in refining the trail layout. The trail design consultant will be providing a cost estimate for the anticipated construction costs. Project biologist is working on the permitting requirements for the project. Trail construction will be a coordinated effort between Parks staff, the trail design crew, and local volunteers. With an estimated volunteer percentage of 35%-45% of the trail construction. Trail construction will have to occur outside of the Mount Hermon June beetle flight season from May 15 to August 15 and all workers will be required to be trained on the sandhill habit ecosystem prior to working.









Santa Cruz Coastal Lagoons & East Cliff Drive Resiliency Study

County Parks was awarded a \$650,000 grant from the State Coastal Conservancy to develop an initial planning-level feasibility study of nature-based adaptation strategies to sea level rise for East Cliff Drive at the three coastal lagoons (Schwan Lagoon, Corcoran Lagoon, and Moran Lagoon) in mid-Santa Cruz County. The goal of the project is to identify a preferred adaptation strategy for each location that prioritizes nature-based solutions, protection of coastal resources and ecosystems, maintenance of coastal access, and protection of infrastructure and property. Staff are currently coordinating project scope with other similar sea level rise adaptation efforts in the region and consulting with scientists and coastal experts to refine and improve the project scope prior to issuing

a Request for Proposals for consultant support. Consultant procurement is expected to start late 2024, and a full project schedule will be developed in early 2025 after a consultant is selected.

South County Parkland Acquisition – Whiting Road

A preliminary park diagram for phase 1 was developed by County parks while a permanent plan is developed. The diagram was shared previously with the Commission. County Parks needs further funding for the park development.

Partnerships with Local Recreation Departments

The organization serve over 1,800 individuals each year with services ranging from crisis intervention, child and youth counseling, confidential shelter, legal support, housing and more. This was Monarch Services 4th Annual "Stronger Together!" 5K / 1K Fun Run and Walk and Community Event. The activities took place at Aptos High School track & field stadium located on 100 Mariner Way in Aptos, CA on Sunday September 22nd, at 9am. The event included children's activities, music, food and community tabling by many local organizations.
- The SC County Parks Department participated in the South County National Night Out "Fight Against Crime" on Tuesday, August 6th at Pinto Lake County Park. The community came out and connected with neighbors. Participating agencies hosting the event included the So. County Sheriff Task Force, Santa Cruz County Office of the Public Defender, Zach Friend Second District Supervisor for Santa Cruz County, Felipe Hernandez 4th District Supervisor for Santa Cruz County, Santa Cruz County Probation, Sheriff-Coroner Dept., California Highway Patrol, Cal Fire, Santa Cruz County Fire Dept., Pajaro Valley Fire and Community Action Board of Santa Cruz County Inc.,. There was free food, drinks and plenty of entertainment for kids and adults (music, crafts, raffles, prizes, games, balloons, and more!

Winter Wonderland Holiday Event

We are very excited to be well into the planning phase for 2024's Winter Wonderland! This event is the upgraded and reimagined Holiday Festival, which last year was called Splash with Santa. This year will include a Holiday Market, Live Entertainment, Free recreation swim, 20+ vendors, an appearance from Santa Claus, and a Pancake Breakfast hosted by our own Recreation Team! We will have large scale decorations, children's performances, and we are hoping to have a very fun time. December 14th at Simpkins Family Swim Center.

New Park Service Officer

We recently brought on an additional Park Service Officer, Jillian Liu, who began training on 10/8/24. By continuing to expand this team, we increase our ability to staff events on late notice, or when the events grow to be longer than a single staff person is able to work.

Bulletin Boards

Emma Lee, with assistance from Merritt Grooms from the Recreation Section, is in the process of identifying locations for all of our existing bulletin boards in county parks. Once all locations are identified, our team will begin creating and sourcing new material to post. Park Service Officers will be able to update the bulletin boards on a revolving basis to create another touchpoint for informing the public about our events, services, and programs.

Concessions Program Update

Since the removal of vending machines in August, our team has successfully launched a new concessions program, which has continued to expand. The program now offers over seven beverage options, along with a variety of snacks such as corn and potato chips, granola bars, fruit leather, trail mix, protein bars, and cup noodles. Melody Barker has taken the lead on the day-to-day operations, receiving significant support from the aquatics front desk team. We are focused on refining our inventory process to improve profitability while maintaining our commitment to serving pool customers, patrons of the Live Oak Library Annex, and County Parks clients.

Upcoming Santa Cruz Public Library Ribbon-Cutting Event

The Santa Cruz Public Library system is planning a ribbon-cutting event for November 23rd. Garrett Smart is representing County Parks at the planning meetings as a liaison. The event will feature a dance performance, remarks by Manu Koenig, and potentially additional elected officials.

Skills of Life Café Debut

We are eagerly anticipating the debut of the **Skills of Life Café** at the Live Oak Library Annex by the end of October. This non-profit life skills program will culminate in food and beverages served to the public by student workers. The café is partnering with Three Waves Coffee to operate as a popup concession, open seven days a week.

Kym Morella, member of the Ben Lomond Village Alliance picked up over 100 plants and Linda Skeff, from the SLV Habitat Restoration Program donated additional plants.

On November 2 over 20 volunteers showed up to install the plants! Volunteers also pulled weeds, installed a visual fence/border, installed drip irrigation emitters, repainted a wooden sign and installed other informational signs. It was a great turnout, and we are looking forward to watching the garden grow!

The Park Hosts will also be trained to help with interpretive programs, volunteer events, and assist with issues at the ranch house when necessary. The Park Hosts have direct communication with Parks staff and the horse boarders to report any issues or concerns that arise at the park.
