#### Introductory Items

##### 1. CALL TO ORDER / ROLL CALL Meeting called to order at 5:03PM.

##### 2. AGENDA MODIFICATIONS No modifications.

##### 3. ORAL COMMUNICATIONS Three members of the public.

Jean Brocklebank: Represented Friends of Corcoran Lagoon Beach and provided an overview of their work. Expressed appreciation for the Coastal Lagoons and E. Cliff Drive Resiliency Study grant. Highlighted educational outreach and ambassador efforts during nesting season. Invited commissioners to visit the group's website for more information.

Mariah Roberts, Executive Director of County Park Friends: Shared that CPF just completed their Strategic Plan and invited the commission to review it on their website and share it with others. Thanked the commission for their help last year spreading the word about CPF's end-of-year campaign. Through all the sharing and communication, they were able to raise \$70k for their access grant scholarship program.

Lynn Dunn: Spoke about concerns regarding ADA compliance in the Live Oak Library Annex and the study room reservation system. Addressed her findings and actions she's taken to work with staff to resolve the issues.

##### 5. COMMISSIONER REPORTS

District 1: Absent.

District 2: Met with Supervisor De Serpa and some members of the public at a small piece of property that is part of the Aptos Village Project. Got to talk about what they would like to see the park become that could better the community.

District 3: Quiet, nothing to report.

District 4: There was a coastal clean-up in District 4. While she was not able to attend, there was great community turnout and help from many organizations like Ecology Action, Watsonville Wetlands Watch, and Supervisor Hernandez.

District 5: Vacant.

## 6. PARKS DIRECTOR'S REPORT

Parks has had several recent successes, despite ongoing County government tensions. Over 500 kids participated in Spring Break programs, and a new Outdoor Education Center quietly opened at Quail Hollow Ranch. In partnership with County Park Friends and the Coastal Conservancy, the Hidden Beach County Park Restroom Project was completed, improving accessibility to the park and beach. A Feasibility Study at the Coastal Lagoons is also underway in collaboration with the Coastal Conservancy.

## 7. INFORMATION/DISCUSSION ITEMS

### a. Discussion on Water Quality Issues at Pinto Lake County Park

Rob Tidmore, Parks Principal Planner, reported that Pinto Lake contains microsystem algae, which produces a neurotoxin harmful to animals in high doses. Algae levels rise in warmer months, limiting recreation. The Regional Water Control Board has set a total maximum daily load (TMDL) for the lake, as nutrient runoff from nearby agriculture may be fueling the algae growth. Parks has contracted BlueWater Science to review past studies and identify data gaps for further action.

- **Commissioner de Sieyes** asked for clarification if phosphorous was the contaminant of concern. Phosphorous and Nitrogen are contributing to large amounts of microalgae.
- **Commissioner Hernandez:** Can the neurotoxin created by the microsystem algae affect people and how is it toxic (touch, consumption, etc.)? The neurotoxin poses a danger, if consumed.

### b. Oral Presentation on the ongoing projects at Moran Lake County Park.

Rob Tidmore, Parks Principal Planner, provided an update on ongoing projects at Moran Lake County Park. These include the Monarch Butterfly Habitat Management Plan (MBHMP) update, tree trimming, native tree planting, and drainage improvements. The MBHMP update process, which began in 2022, involved collaboration with stakeholders, consultants, and monarch experts, resulting in a public draft released in Summer 2024. The wind study examined how the tree canopy impacts wind protection for monarch overwintering sites and recommended tree management actions to reduce tree failure risk while preserving monarch habitat. Funding from County Risk Management and the wind study findings will support tree work starting in late May. The continuation of native tree planting and drainage improvements from last year will also proceed.

#### ○ **Public comments:**

- One member of the public expressed appreciation towards the updates to the MBHMP and restoration to County biological resources.
- A Placer Street Resident shared concerns about tree trimming plans and the amount that has been done on Placer Street.
- Another Placer Street Resident thanked the Parks Department for the work that they are doing in the Moran Lake area.
- *One member of the public asked if the trimming that is beginning later this month, would reduce trees to 70' or 80' height.* Rob Tidmore clarified that the work is to reduce height and canopy volume to a safe height that reduces the possibility of the tree falling. The wind study

used the 70' measurement as a model, but that height may not be possible at this time because a large reduction to a tree's height could cause health concerns to the tree itself.

c. Informational Overview of the Santa Cruz County Parks Proposed FY2025-26 Budget.

Director Gaffney provided a brief overview of the Santa Cruz County Parks Department for Fiscal Year 2025-26. He explained the expenditures and revenues of the department, as well as some of the major changes in the different divisions that will be affecting the budget. Since the budget has not been presented to or approved by the Board of Supervisors, it may be subject to some changes prior to its finalization for the year.

- **Vice-Chair Sanford:** *With the concern expressed about water and field usage, have you considered the use of artificial turf?* The Parks Department has considered it over the years and recently revisited the potential. There is a benefit to making the change, but the initial construction costs are proving to be a barrier.
- **Commissioner de Sieyes:** *Were there any capital projects included in this budget?* No, the capital projects budget is still being worked through.
- **Public Comments:**
  - *One member of the public asked if the department received any of the impact fees that had been collected and where they are accounted for.* The impact fees have started to be collected, but some of the calculations are being reevaluated. There is a new statute that does not allow Parks to collect the fees until the entire project is signed off. The impact fees are being collected in one spending bucket, to increase the project possibilities.

## 8. ACTION ITEMS

a. Select the name of the new South County Park for recommendation to the Board of Supervisors.

Sarah Shea, Parks Superintendent, shared name options for the new South County Park. She explained that County Parks and County Park Friends worked with a naming committee and a youth Park Project Group to develop six potential names. Students at Alianza Charter School voted on them, and the top three were presented to the Commission for consideration:

“Pajaro Valley County Park” (Valle del Pajaro County Park)

“La Flor del Valle County Park”

“Valle Verde County Park”

- **Commissioner de Sieyes** *asked for further clarification on what the students from Alianza School voted for.* “Pajaro Valley County Park” was the name that was presented and the students expressed an interest in the name but translating it to Spanish. Staff then presented the name in Spanish as a fourth option and the students voted for it.
- **Vice-Chair Sanford:** *How binding is this name choice? Could a donor make a difference in the name choice?* The Commission is making a recommendation to the Board of Supervisors to accept this as the park name. Donors would not have a final say in the name of the County Park.
- **Commissioner Hernandez** *asked for more information on the history of the area. Since this park is in the outskirts of town, is it still considered Pajaro Valley?* Yes, when the Spaniards arrived in the area, they saw a statue of a bird and chose to refer to this area as the Pajaro Valley.
- **Commissioner Hernandez** *also voiced a concern for the name “Valle Verde” and its association with gangs in the area.*

**Motion** to support “Valle del Pajaro County Park” as the name for the new South County Park located on Whiting Rd.: Hernandez/**2<sup>nd</sup>**: de Sieyes/All in favor.

From May to now, we've had a strong and successful summer, with a consistently busy pool deck and high participation across all our programs:

### **Junior Guard & Little Guard Programs**

Both programs saw excellent growth this year.

- Junior Guard Program (Ages 7–13): 415 participants from June through August — up from 360 last summer.
- Little Guard Program (Ages 5–6): 188 participants — up from 150 in 2024

We were fortunate to have five Junior Guard volunteers assisting with the program and supporting our team.

### **Private Swim Lessons**

Private lessons remain in high demand.

- Our two long-time private contractors were fully booked, serving 59 participants.
- A third private contractor joined us in June and has already worked with 22 families.

### **Swim Lesson Instructor Training**

We ran our semi-annual Swim Lesson Instructor Training from May 27 to June 6, training 18 new instructors. To support their development, we offered discounted swim lessons to the public, which received an outstanding response with 288 participants enrolled.

### **Group Swim Lessons**

Group swim lessons have continued to thrive with 783 participants enrolled so far this summer.

### **Pool Rentals & Community Events**

- We hosted 12 schools for private pool rentals as part of their end-of-year celebrations.
- We also held two free community swim days for Memorial Day and Independence Day, which were very well received.

### **Adult Fitness Programs**

Adult Fitness continues to be one of our most popular offerings:

- Classes are held Monday/Wednesday/Friday at 6:00–7:15 AM and 7:15–8:30 AM, and Saturday at 9:00 AM.
- We've had a total of 2,372 participants enrolled in these sessions this summer.

- Due to the popularity of these classes, we've hired a new private contractor who will launch a new noon workout on Monday, Wednesday, and Friday.

### **Fall Lifeguarding Courses**

Looking ahead to fall, we have four Lifeguarding classes scheduled.

Due to strong demand and consistent instructor availability, we are increasing capacity from 10 to 20 participants per class to help more individuals become certified lifeguards.

### **Coming Soon - Simpkins Swim Club!**

There has been a lot of interest in having a swim team through Simpkins. We are starting off small, but hopefully with advertising and word of mouth, we can grow into a large program for the community.


### Percent for Art Public Art Projects

**Juvenile Hall** - The County Arts Commission approved the selection panel's recommendation of public artist for the Juvenile Hall Facility. The artist's proposal and agreement will go to the Board of Supervisors for their consideration in September.



Shaun Logan completed a public art mural on the new restroom building at **Hidden Beach Park** (photo on the left). The mural features what a park visitor might see as they make their way down the path to the beach: Monterey Bay, the seawall, flowers, a breaking wave, foliage and a songbird. He also designed way-finding signs to direct park visitors to the beach, and beachgoers to the restroom facility.

Justin Francavilla completed the public art project at **Floral Park**. The "Life of the Tide Pool Party" features tide-pool dwelling creatures on two bronze sculptures and a bronze plaque (photo on the right). The plaque offers park visitors the opportunity to make a rubbing of the artwork with crayons and paper, taking their own copy of the art home.

### **North County, Highlands and Emeline Maintenance Shops**

The North County Maintenance team mowed the large Eucalyptus lot at the Emeline campus for weed control and fire prevention.

Maintenance has been sand dressing and leveling the fields at Anna Jean Cummings Park, this effort also includes gopher abatement, irrigation adjustments and repairs, seeding and fertilizing.

Quail Hollow Ranch and Anna Jean Cummings Parks received seasonal mowing of the open spaces for fire prevention, this was scheduled for after ground nesting birds have fledged.

The remaining Eucalyptus trees at Moran Way and East Cliff have been removed from the lot and stumps are being ground. The next steps are to grade the area for drainage, and replant with native trees and shrubs for mitigation of removed trees.

A new drinking fountain was installed at Floral County Park next to the playground. Native plantings have been planted around the playground with support from our maintenance team.

The Miller Property in Boulder Creek has a newly installed parking area, split rail fencing, signage, and picnic areas, all completed by our Park Maintenance staff.

The North Coast Beaches are very busy this time of year, Maintenance is spending a lot of time cleaning up garbage and restrooms as well as reestablishing our responsibility at Greyhound Rock by reinstalling park rules signs, changing locks, and opening the vault toilets for public use.

The maintenance team recently replaced the shower valves at Pleasure Point and the Hook. They are also preparing the Moran Lake County Park restroom for full interior and exterior painting, along with new fixtures, lighting, and doors. Additionally, the team helped to install educational signs about tide pools at several coastal access points along East Cliff Drive (Pleasure Point, 38<sup>th</sup>, The Hook). The team assisted our great volunteers for a day of chainsaw work on the Pace trail at Quail Hollow Ranch. Look out for Yellow Jackets this time of year!

### **Mid County, Simpkins and Felt Street Maintenance Shop**

Maintenance staff spread new wood chips around the Live Oak Library Annex and the back patio area of the swim center.

New engineered Fibar was installed at Hestwood County Park in the playground.

Jose Avenue Park has received turf restoration work, and Gopher abatement.

Jose Avenue, Brommer Street, Felt Street and Hestwood restrooms have received a fresh coat of paint, fixture and lighting upgrades have also been installed as needed.

The team also worked on Ivy and Poison Oak removal at Twin Lakes County Park.

Maintenance has just completed a large clearing project at Brommer Park to clean up the areas around the picnic pavilion and the playground.

### **South County, Pinto Lake and Aptos Polo Grounds Maintenance Shops**

The South County Maintenance team removed a hazardous Eucalyptus tree and Oak tree at Pinto Lake County Park.

The Disc Golf course at Pinto Lake is busy at this time of year! The maintenance team is staying busy keeping the areas cleared back from the walking paths, and keeping the open fields mowed.

We had a successful grand opening for our new south county park, Valle Del Pajaro! There was an excellent turnout of friends, neighbors, county staff, and elected officials. Come on out and see the new park!

There has been a lot of activity around the front of Pinto Lake County Park and Mesa Village County Park with the construction of the Green Valley Road Pedestrian Walkway. We have planted trees at Mesa Village with the help of Watsonville wetlands watch and plan to install new fencing soon.

The maintenance team has been working on the athletic fields at Pinto Lake County Park and Polo Grounds County Park. The work includes filling holes and grading the decomposed granite pathways around the fields.

The Bollard Lighting at Willowbrook County Park is being replaced with new fixtures and more efficient LED lighting.

Polo Grounds, Seascape, Pinto Lake, and Valle Del Pajaro have all received seasonal mowing of the open spaces for fire prevention.

A new public restroom was installed at Hidden Beach and our crews have been working on maintaining and cleaning the new restroom and maintaining the new landscaping around it.

### **Seasonal Maintenance County Wide**

Every year Parks Maintenance maintains our sports fields for safety and playability at Pinto Lake, Polo Grounds, Anna Jean Cummings, Brommer, Michael Grey and Highlands Park. This work consists of irrigation maintenance, rodent control, fertilizing and spot seeding/top dressing, and consistent summer mowing schedules. These efforts set us up for success when it comes to off-season renovations and restoration projects for our athletic fields.

### **Maintenance Staffing Changes**

County Parks is preparing to fill upcoming vacancies within the Parks Maintenance team. We have two team members who are retiring, so the department will be looking to fill these positions in the next few months.

Congratulations to Bernardo Chow and Blanca Rocha! While the department is sad to see them go, we are happy to see them enter the next phase of their lives. These will be big shoes to fill, as both Bernardo and Blanca are talented, hard-working individuals with vast institutional knowledge of the Parks Department.

### **Vehicle/Equipment Update**

Parks Maintenance will be getting a new fleet vehicle this week for the Maintenance team that oversees the swim center and surrounding parks.

We have also placed orders with our local John Deere vendor for a couple new lawn mowers, currently we have 2 lawn mowers that are being repaired, and we are trailering the remaining mowers all over the county to get the weekly mowing completed for our athletic fields, playground areas, picnic areas, and wedding lawns.

### Coastal Rail Trail

Segments 10 and 11: Final design for the project began in early May and the team is working to incorporate suggestions from the RTC-led value engineering study conducted in 2024. Updated designs and cost estimates for the project are expected in late Summer.

Ecology Action is continuing to lead the non-infrastructure programming portion of the project, coordinating with 10 area schools on bicycle and pedestrian education classes, and the creation of a community incentive program that will target low-income monolingual Spanish speaking residents of Live Oak, Pleasure Point, and Capitola. Additional pedestrian and bicycle classes at area schools are scheduled for Fall 2025.

North Coast Rail Trail (Segment 5): The RTC expects to open the Panther/Yellowbank parking lot to the public this fall prior to the rest of the project opening in Summer 2026. The purpose of the early opening of the parking lot is to minimize impacts to public coastal access. The trail itself will not be open. As part of the Maintenance Agreement for the project, County Park and Public Works will be maintaining the trail on behalf of the RTC. An addendum to the Maintenance Agreement went to the Board of Supervisors on August 5<sup>th</sup> for approval for Parks staff to begin early maintenance of the parking lot.

### Freedom Lake Restoration Plan

Freedom Lake, a cherished natural resource for both wildlife and the local community, has faced ongoing challenges from invasive species that disrupt native habitats and degrade water quality. Watsonville Wetlands Watch (WWW) is actively maintaining the area where Acacia was previously removed and native vegetation was installed. The native plantings are establishing well, and efforts to control Acacia resprouts are ongoing.



Maintenance activities will soon expand to include the area cleared by the County along Freedom Boulevard. Remaining cut material will be processed, and the site will be covered with weed matting. This area will also be added to WWW's regular maintenance schedule.



In parallel, WWW is collecting background data to inform planning studies. Through December, the Working Group will prepare a background memo outlining preferred alternatives for the site.

### **Greyhound Rock**

Parks staff have initiated feasibility studies to assess potential biological, geological, and cultural constraints related to the cabin project. These studies will help identify suitable locations for the development of the environmental education center and cabins. Results from the initial feasibility phase are expected in late summer 2025.

### **Hidden Beach County Park**

The project is complete, and the public art mural has been finalized.




### **Moran Lake County Park**

Monarch Butterfly Habitat Management Plan: County Parks, in collaboration with the Santa Cruz County Sanitation District and the First District Supervisor, held a community meeting on June 24<sup>th</sup> to discuss the results of the wind study and proposed changes to the draft Monarch Butterfly Habitat Management Plan (HMP) based on the data collected by the wind study. In summary, the draft HMP will clarify that habitat management will prioritize public safety, protection of monarch habitat, and restoration of native species and habitat for biodiversity, in that order. The HMP will also outline regularly recurring, proactive arborist inspections to assess grove risk, hazard abatements as identified, regular maintenance of trimmed trees, continued drainage improvements to reduce ponding at the base of trees, and ongoing native tree and shrub planting.

Tree Work: Based on the data from the wind study, County Parks has begun tree trimming and tree removal work around Moran Lake County Park to improve public safety and ensure the long-term viability of monarch overwintering habitat. All the eucalyptus trees have been removed from the 40 Moran Way parcel, and

drainage improvements are expected to be completed this fall, with native tree planting and restoration of the parcel occurring this winter, conditions permitting. Tree trimming of the South and North Lakeside areas is currently underway. The ongoing tree work is science-based and is part of Parks' ongoing efforts to manage monarch habitat at Moran Lake while prioritizing public safety and increasing climate resilience.



### **Pace Property Connection Trails**

Pace Property Trails will bring residents through the sandhill habitat, one of the rarest ecosystems in the United States and found only in Santa Cruz County. Project trail layout and flagging have been completed. Volunteers from Friends of Quail Hollow Ranch have been hard at work removing invasive French Broom and hand cutting sections of the loop trail while the

sandhill habitat area is closed during Mount Hermon June Beetle flight season (May 15 – Aug 15). Parks staff have assisted with volunteer coordination and intermittent saw work to remove downed trees. A larger volunteer-supported trail building effort is planned for the fall after the Mount Hermon June Beetle flight season. Parks' Volunteer Coordinator will work with Santa Cruz Mountains Trail Stewardship (SCMTS) to recruit volunteers for this work. The project biologist has submitted the permitting requirements for the project with U.S. Fish and Wildlife Service. Trail construction will be a coordinated effort between Parks staff, the trail design crew from SCMTS, and local volunteers, with an estimated volunteer percentage of 35%-45% for the trail construction.



### Santa Cruz Coastal Lagoons & East Cliff Drive Resiliency Study

County Parks was awarded a \$650,000 grant from the State Coastal Conservancy to develop an initial planning-level feasibility study of nature-based adaptation strategies to sea level rise for East Cliff Drive at the three coastal lagoons (Schwan Lagoon, Corcoran Lagoon, and Moran Lagoon) in mid-Santa Cruz County. The goal of the project is to identify a preferred adaptation strategy for each location that prioritizes nature-based solutions, protection of coastal resources and ecosystems, maintenance of coastal access, and protection of infrastructure and property.

A contract with Environmental Science Associates (ESA) to conduct the study was awarded by the Board of Supervisors on June 24<sup>th</sup>. A project kickoff meeting was held in July, and monitoring work at the three lagoons has begun in partnership with California State Parks and Santa Cruz County Environmental Health. The project team is developing a Technical Advisory Committee and Interested Party List for communication and distribution of project materials. A public-facing project website is expected to be ready this fall with background information.

### South County Parkland Acquisition – Valle del Pájaro



In 2024, County Parks, in collaboration with its nonprofit partner County Park Friends, hosted and participated in a series of community events to gather feedback on potential temporary uses for the site, which is currently zoned for Commercial Agriculture. Through these outreach efforts, over 1,000 community members shared their input by ranking their top three preferred temporary park features. The highest-ranked priorities included a natural play area, picnic areas, and natural trails.

In response to this community input, and with the goal of beginning to provide public access to the future park—County Parks implemented a small parking lot, an access pathway, and a



half-mile loop trail with benches and picnic tables. These amenities were officially opened to the public on July 11.

As for long-term planning, the County has selected a consultant (Mithun) to lead the development of a Master Plan, with a strong emphasis on community engagement throughout the process. The Master Plan work is expected to begin this fall.

### **Partnerships with Local Recreation Departments**

- The Recreation team supported transportation and positive recreational experiences through its partnership with County Park Friends, offering collaborative programs as part of the ParkRx and Outdoor Equity initiatives across the county. A field trip to Big Sur was held on July 8th, and two Sports Fusion programs were conducted at Mesa Village in Watsonville.
- The Recreation team secured a contract with Pajaro Valley Unified School District to provide free camps at Mar Vista Elementary School during summer break. Camp Taking on Summer (TOS) ran from June 9th to August 6th.
- The Recreation team continues its partnership with the Capitola Branch Library to host Bridge Club sessions, which take place every Monday from 10:30 a.m. to 12:00 p.m.
- The Mall Walkers program, hosted at the Capitola Mall, continues through a standing agreement. The program meets on Mondays, Wednesdays, and Fridays from 9:30 a.m. to 11 a.m.
- Family Fun Day 2025 was hosted by the Scotts Valley Recreation team at Skypark on Saturday, July 19th. This collaborative event brought together Parks teams from the City of Santa Cruz, City of Watsonville, and Santa Cruz County Parks. This free, family friendly event was celebrated as part of July is Recreation Month and was a successful countywide effort!
- The Recreation team joined the San Andreas Regional Center's Superhero Festival at Chanticleer Park on Saturday, July 19<sup>th</sup>. There were games, activities, free backpacks, face painting, and, of course, Superheroes. This event was an inclusive family friendly event for all to enjoy.
- The County Parks Aquatics Team hosted two basic CPR Certification courses for Recreation staff on June 22<sup>nd</sup> and July 20<sup>th</sup>.
- County Parks teamed up with the South County Task Force to host the annual National Night Out event on Tuesday, August 5<sup>th</sup> at Pinto Lake County Park.

### **Recreation Programs & Contractual Agreements**

- Summer camps were offered at four parks throughout the county – Highlands County Park, Quail Hollow Ranch County Park, Mesa Village County Park, and Aptos Village County Park. From June 9<sup>th</sup> to August 6<sup>th</sup>, participants enjoyed a wide range of enrichment activities including games, arts and crafts, sports, cooking classes, and local field trips.

- The County Parks team plans to extend its contract with El Palomar Ballroom to continue offering Big East Swing classes and introduce an additional Salsa Dance class for active adult participants this fall.

### **Marketing Efforts**

- The Department is currently developing the Winter and Spring Activity Guide, which will promote seasonal programs scheduled between December 2025 and May 2026.
- Marketing efforts continue to include the creation of bilingual flyers (Spanish/English) as well as regular social media updates to promote events and programs.

We have held three Food Truck Fridays serving over 120 community members. Each event has had its own unique vibe, and the vendors have varied from month to month. ### **Facility Reservations**

### 701 Ocean St. County Building

## Quail Hollow Ranch County Park


