# V. Staff reports

Shaun Logan completed the mural on the new restroom building at Hidden Beach – it has been well received by the public. The Spotlight Awards exhibition opens August 1 – join the artists for First Friday, 5-7PM on the 5th floor of the County Gov. Ctr. Justin Francavilla is installing the public artwork at Floral Park – the "Life of the Tide Pool Party" features tide-pool dwelling creatures on two bronze sculptures consisting of a bronze-relief plaque and a cast bronze sculpture. Bruce Harman has completed installation of the Green Valley MUP public art project, which features 5 painted concrete monoliths situated by new bus stop; Children from Amesti Elementary created ceramic tiles which art installed along the top edge of each monolith.

Santa Cruz County Parks offers small grants for community partners to provide cultural and recreational programs to communities the department has historically been unable to reach and serve. More information and the application can be found on the Parks website. Applications are due August 15. The department opened the new Valle del Pájaro County Park last week, the first park with a Spanish name in county history The 10<sup>th</sup> Annual Parks and Rex pool party will be held August 16 from 11AM-4PM at the Simpkins Swim Center. There will be something for everyone to enjoy, including your dog! Registration is not open for dog swim time slots and entry tickets.
