<u>Live Oak Exhibits Program - Procedures</u>

Participating facilities:

Simpkins Family Swim Center: all public wall space that this is managed by the County Parks Department.

Sheriff's Center, 1st District Supervisors' Office (TBD)

Definitions and understandings:

"Live Oak" is the area served by the Live Oak School District.

"Appropriate imagery" does not contain religious or political subjects, nudity, drug use, or violence are not acceptable.

"Professionally framed" is artwork that is professionally presented and ready to hang from tracking hooks, not exceeding the weight or size limitations provided to artist.

"Live Oak centered work" is Live Oak subject matter including history, locations, people, flora and fauna, etc. and artist/exhibitor residence in Live oak.

Artists/exhibitors, non-student work, are responsible for hanging and taking down their own work.

Procedures:

A) Student work

Determine which wall will be reserved for rotating exhibitions of LOSD student work. Parks Arts Program staff (Parks) will coordinate with schools/art teachers regarding time slots, number of pieces, display requirements, installation assistance from teachers/students/volunteers, returning work to students, signage, etc.

- B) For all other walls, Parks Staff will:
 - Establish a simple application process, similar to current Government Center Application
 - Work with community organizations and arts groups to get the word out to the Live Oak area about exhibition opportunities. Include in Call to Artists potential preferred subject matter and note the Live Oak residents have priority

- Form a panel each year during November that meets in early December annually to review artists' application images and rate each. The panel would include Arts Commissioners (2), local artists (2), community members (2), Parks Arts Program staff (1) – seven total members.
- Compile scores to determine which artists will have the option to show their work.
 - Note: Applications that are *Live Oak Centered* would be prioritized for show slots, but the work to be exhibited must be *appropriate* for the facility and *professionally framed*. Only if there are not enough Live Oak artists to fill the available time slots would artists who have been vetted by the Gov. Ctr. Exhibits Panel be contacted by Parks about showing their work.
- Contact artists/exhibitors with time slot available confirm participation.
- Ensure required forms and other information are completed and filed, such as artist contract, exhibit insurance information and exhibit cards, bio and images for promotional purposes.
- Coordinate installation and deinstall dates.

Gail Rich Awards Photo Collection Donation

Background - When someone proposes to donate artwork to the County, the Arts Advisory Panel (AAP) meets to review the proposed donation on the basis of aesthetic quality, relationship of the artist or artwork to the County of Santa Cruz, historical art context, condition of the art work, maintenance requirements and appropriateness for public display. The AAP is comprised of an appointed Arts Commissioner, the Parks Dept. arts programs staff, and three artists and/or arts professionals (e.g. museum or gallery curator). The AAP reviews the materials and makes a recommendation to the County Arts Commission to accept or reject the donation.

Recommendation: The AAP recommends that the Arts Commission accept this donation into the County Art Collection. It consists of a digital collection of 150 photos, as well as prints of each photo. See attached list for all awardees and year of award.

About Gail Rich - She was an inspiration to our community. In addition to being active in a number of local arts organizations – and a proud supporter of many others – she spent several years as a member and chairperson of the Arts Council Associates and served on the Arts Council Board of Directors. The broader community knew her as a Sentinel arts correspondent and a classical music programmer on KUSP. Gail died unexpectedly on October 5, 1996 at the age of 45.

Gail Rich Awards Program - Named after the late Gail Rich who embodied the spirit of appreciation for the arts, the Gail Rich Awards were a way of singling out the faces that enhance our community with their commitment, talent and vision. This annual awards event celebrated the spirit of the arts in Santa Cruz by recognizing those who inspire our diverse and culturally-rich community. Awardees were nominated by community members and chosen by Wallace Baine, then Entertainment Editor for the Santa Cruz Sentinel, and photographed by Sentinel photographer Shmuel Thaler. The awards were presented at "The Gailies" – an annual free event produced by the Arts Council Associates.

Photographer Bio: Shmuel Thaler has been a staff photographer at the Santa Cruz Sentinel since 1987. He has won numerous awards, including having his photography named the best photojournalism in the state of California in 2022 by the California Newspaper Publishers Association. He was named the 2016 Santa Cruz County Artist of the year and his photographs have appeared in every major newspaper in the United States. He spent much of 2020 documenting Black Lives Matter actions, the CZU August Lightning Complex fires and the pandemic for the Sentinel. His photograph of Santa Cruz Police Chief Andy Mills and Mayor Justin Cummings taking a knee at a BLM action organized by Joy Flynn in the aftermath of the George Floyd murder went viral and aired on every major TV network. The image was shared by Octavia Spencer, Katie Couric and George

Conway and thousands of others, was seen by millions and was included in the International Center of Photography's #ICPConcerned exhibit. Shmuel received his BFA from the film school at New York University's Tisch School of the Arts and his photographs illustrate numerous books including his collaboration with the late Santa Cruz author George Levenson on 'Bread Comes to Life' and the classic 'Pumpkin Circle', which has more than 120,000 copies in print and is held by most library systems in the country. He lives in Santa Cruz with his wife Kathy Cytron in the home where they raised their two daughters Kayla and Hannah.

- Dates: Thursday, April 16 Saturday April 25 or Sunday April 26, 2026 (need to discuss finale / festival end date)
- **Goals:** Establish Santa Cruz as a renowned arts destination. Build partnerships and collaboration across venues. Pilot program focuses on local engagement, with plans to expand regionally and nationally in future years
- Opening with Dance Week's "Dancing in the Streets" event.
- Dates align with Arts, Culture, and Creativity Month in California and Santa Cruz

Committees

- 1. **Festival Events Team** Responsibilities include collaborating with organizations and venues to envision, plan, and develop a comprehensive schedule of events for the festival. Key discussions will address criteria for venue participation; brainstorming event ideas for youth, seniors, and other groups; bridging north and south counties; exploring the possibility of a VIP fundraiser/reception; considering a passport system to engage attendees; and explore potential collaborations between visual & performing arts. Think through creative transportation sources (special bus routes / shuttle service, etc). Currently 7 members
- 2. **Finale Event Team, Saturday, April 25** responsibilities include envisioning, planning, organizing, and executing the finale celebration, including scheduling performances, managing logistics, coordinating with local artists and vendors. Currently 8 members
- 3. **Marketing / Public Relations / Graphic Design Team -** responsibilities include creating a marketing / advertising strategy and outreach, designing marketing materials, and ensuring consistent branding. Currently 8 members.
- 4. **Fundraising / Sponsorship / Grant writing Team -** responsibilities include securing financial support for the festival through sponsorships, grants, and donor outreach, as well as securing hotel and restaurant packages. Currently 6 members (including Commissioner Miranda)

- 5. Finance Manager / Treasurer We are in conversation with the Arts Council about fiscal sponsorship. We will need a lead who can manage the budget, track finances, and ensure responsible use of funds for the festival.
- 6. **App Development Team** researches, designs, and develops a user-friendly app to guide attendees, providing event schedules, venue information, and interactive features for the festival. Currently 3 members.
- 7. **Public Art Team** coordinates the planning, placement, and execution of public art installations, collaborating with artists, venues, as well as the city and county of Santa Cruz. Currently 6 members.
- 8. **Volunteer Coordination Team-** as the festival planning evolves, responsibilities will include recruiting, organizing, managing and supporting volunteers. No members yet.
