# SANTA CRUZ COUNTY ARTS COMMISSION'S FINDINGS PURSUANT TO ASSEMBLY BILL 361 AUTHORIZING TELECONFERENCEMEETINGS AS A RESULT OF THE CONTINUING COVID-19 PANDEMIC STATE OF EMERGENCY AND HEALTH OFFICER RECOMMENDATION FOR SOCIAL DISTANCING

**WHEREAS**, the Arts Commission is a legislative body under the Brown Act as defined under Cal. Gov. Code section 54952(b) and Santa Cruz County Code Section 2.38.110; and

WHEREAS, on September 16, 2021, Governor Newsom signed Assembly Bill 361 ("AB 361"), urgency legislation effective immediately, that amended Government Code section 54953 to permit legislative bodies subject to the Brown Act to continue to meet under modified teleconferencing rules provided that they comply with specific requirements set forth in the statute; and,

**WHEREAS**, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(1)(A), a legislative body may meet under the modified teleconferencing rules during a proclaimed state of emergency, and where local officials have imposed or recommended measures to promote social distancing; and

WHEREAS, on March 4, 2020, Governor Newsom issued a Proclamation of State of Emergency in response to the COVID-19 pandemic, and which remains in effect; and

WHEREAS, on September 30, 2021, Santa Cruz County Public Health Officer Dr. Gail Newel strongly recommended that legislative bodies in Santa Cruz County continue to engage in physical/social distancing by meeting via teleconference as allowed by AB 361 and confirmed that she will regularly review and reconsider this recommendation and notify the public when it is no longer recommended; and

WHEREAS, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(3), within 30 days of the date the legislative body first holding a teleconferenced meeting under the modified rules, and every 30 days thereafter, a legislative body can continue to hold such teleconference meetings provided it has reconsidered the circumstances of the state of emergency and determined either that the state of emergency continues to directly impact the ability of the members to meet safely in person or that local officials continue to recommend measures to promote social distancing; and

**WHEREAS**, on March 7, 2022, the Arts Commission held an initial teleconference meeting under AB 361; and

WHEREAS, this Commission has reconsidered the circumstances of the current state of emergency and finds that the COVID-19 pandemic continues to directly impact the ability of members of the public to participate safely in person and further finds that the Santa Cruz County Public Health Officer continues to recommend measures to promote social distancing; and

**WHEREAS**, in the interest of public health and safety, and due to the emergency caused by the spread of COVID-19, the Arts Commission deems it necessary to utilize the modified teleconferencing rules set forth in AB 361;

**NOW, THEREFORE**, the Arts Commission makes the following findings by a majority vote:

**Section 1.** The foregoing recitals are true and correct, and adopted as findings of the Arts Commission.

**Section 2**. Effective immediately, and for the next 30 days, the Arts Commission will meet via teleconference as authorized under AB 361 and Government Code section 54953(e)(3).

**Section 3.** No later than thirty (30) days from making today's findings, or at the next scheduled meeting, the Commission will reconsider the circumstances of the COVID-19 state of emergency and, if necessary, adopt subsequent findings to continue holding teleconference meetings in accordance with Government Code section 54953(e)(3).

#### Santa Cruz County Spotlight Award – honoring emerging artists

#### Objective:

Through the Spotlight Award, the County of Santa Cruz publicly recognizes individuals who have achieved a high level of excellence and creativity in their work, but who have not received widespread acknowledgment of their talent. This award recognizes younger artists as well as those who are discovering their artistic voice later in life. Judging criteria will include the effective use of media and tools to communicate their own personal style.

#### **Eligibility Criteria:**

- Artist must be nominated by a resident of Santa Cruz County.
- Artist must be a current resident of Santa Cruz County.
- Artist must have completed works that show a high degree of excellence, individuality, innovation, and/or creativity.
- Artist must show significant artistic promise, as demonstrated in a significant achievement for at least one completed piece of artwork, performance, exhibit, or written work, recognized by critics, educators or professionals.
- Artists working in any medium are eligible, including literary, visual, and performing arts.

#### About the Award:

Awarded artists will be provided a certificate of merit to be awarded at a Commission meeting. The County of Santa Cruz will publicize the award. When funding is available, artists may be honored at a public reception.

#### **Nomination Process:**

The Spotlight Award nomination period will open on\_\_\_\_\_\_, and close on\_\_\_\_\_ of each year. Only residents of Santa Cruz County are eligible to make nominations. Nomination forms must be accompanied by a single page letter, which includes:

- The name of the artist and their contact information, including: e-mail, website (if available), phone and local address
- A brief description of your relationship to the artist, why you are nominating them for the award, and how they meet the criteria (how they stand out as an emerging artist).

#### Final Draft

Santa Cruz County Parks will notify the nominees and provide them with the submission information. Nominees must return their submission materials by the required date to be considered. A new process will open each year. Materials will **not** be carried over into the next year, but artists previously considered may be nominated again in subsequent years.

#### **Selection Process:**

The selection panel is composed of members of the Santa Cruz County Arts Commission, which is made up of up to ten commissioners appointed by their district Board of Supervisor.

If a large number of nominations are received, the Santa Cruz County Arts Commission may convene an outside panel of community members to conduct an initial screening.

The panel will review eligible applications, and the artists will be selected based on materials provided which documents:

- Excellence in the body of work presented
- Effective use of media and tools to communicate personal style
- Innovation/creativity
- Nomination letter



#### ARTS COMMISSION 2021-2022 BIENNIAL REPORT

#### **ROLE OF THE COMMISSION**

For the benefit of the citizens of the County of Santa Cruz, the Arts Commission is responsible for advising and making recommendations to the Board of Supervisors and the Parks Department staff on all matters relating to the encouragement and coordination of artistic and cultural affairs within the County. In addition, the Commission:

- 1. Identifies and addresses the unmet needs of cultural and artistic life in Santa Cruz County.
- 2. Serves as advocates for the arts, soliciting multiple sources to support artistic and cultural programs in Santa Cruz County.
- Communicates and cooperates with the County of Santa Cruz, Department of Parks, Open Space and Cultural Services and related Commissions, community and private resources and arts-related groups performing as contractors, in order to ensure coordination of arts and cultural activities.
- 4. Assembles and makes available to the public up-to-date information relating to Santa Cruz County's artistic and cultural resources.
- 5. Is responsible for Arts Council oversight for the Board of Supervisors and conducts an annual review in June.
- 6. Helps facilitate public and private partnerships for the Arts in Santa Cruz County.

#### **MEETINGS AND STRUCTURE**

The Arts Commission meets no more than six times each fiscal year, with meeting dates to be determined by the Commission based on program needs. Meetings are generally held at 4:30 p.m. in the Parks Department conference room. Due to the Covid-19 pandemic, meetings held in 2020 and 2021 were held online, via the Microsoft Teams app.

The Arts Commission is made up of ten members, two nominated by each Supervisor, which operates using the Sturgis Rules of Order and a structure that includes a Chairperson and a Vice-Chairperson. Staff support is provided by the Department of Parks, Open Space and Cultural Services.














### Teen Area Sculptural Panel Fence Design Without Collaborative Elements





The Northwest panel artwork that flanks the gate will be 69"H & 21.75"W. The gate panel artwork will be 23"W x 61" H (allowing for framing). Posts to be 3" square tubing1/4" thick weathering steel. Framing of the gate panel to be concealed by the metal artwork so that it works with the arching banana slug feature central to the top edge of the gate.






### Children's Garden - Southeast Panels / Gate Design Mockup



The Southeast panel artwork that flanks the gate will be 69"H x 17"W. The gate panel artwork will be 23"W x 61" H (allowing for framing). Posts to be 3" square tubing1/4" thick weathering steel. Framing of the gate panel to be concealed by the metal artwork so that it works with the arching sorel stem feature central to the top edge of the gate.

### Proposed Location - Children's Garden Area



The Children's Garden Panel / Gate sets will consist of 3 weathering steel panels each with glass inserts. The inserts will have a base pattern to represent the bark of redwood trees with various elements from the redwood forest (sorrel, ferns, mushrooms, and of course, banana slugs). Each set features a center hinging gate allowing for a 36"W clearance between posts. Latches & hinges tbd.

### Proposed Location - Teen Area



The proposed artwork will consist of a weathering steel & kilnformed glass sculptural panel composition to be constructed to create fence line approx. 18'2"L (see above). Panels will be 69"H x 23"W comprised of 16 gauge weathering steel with 2" posts of 3/16" tubular also in weathering steel with 3" spacing between each panel/post assembly. The base design will be an abstracted wave element running through all of the panels. Artist intends to reach out to the Advisory Council of Teens to present this portion of the design & solicit ideas for engaging the Aptos High School art students for inspiration about additional imagery.

We appreciated the survey provided to us and since being notified of our selection for the Live Oak Library Annex public art project. We have additional information that we would like to update the selection committee. The *Letters* sculpture that we are proposing will be powder coated in sparkling ocean blue color (you can see the sample color here) <a href="https://www.prismaticpowders.com/shop/powder-coating-creations/716">https://www.prismaticpowders.com/shop/powder-coating-creations/716</a> to reflect the ocean environment of Santa Cruz and in consideration of the community that wished to see color in the chosen artwork. We feel that the color will be brilliant and inviting to the neighborhood and the Santa Cruz community as a whole. The sparkling ocean blue powder coat will not only look striking and amazing but will protect the sculpture from all elements including the ocean breeze.

The *Letters* will be very statuesque in the Live Oak Library Annex complex and impart a long-lasting message of how important their library complex is in their lives. As a place of learning and education as well as other important community activities, the people of Santa Cruz will come to identify the area by the impressive figure of *Letters* on the grounds of the Live Oak Library Annex as a first point of contact for visitors.


#### <u>Fabrication and Installation</u>

The fabrication and construction of the *Letters* will take approximately 2-3 months and will be ready to install on-site with Titen bolts with epoxy at multiple points to the sculpture by professional art movers and installation team for maximum safety and stability. The Sculpture will not have any sharp edges due to sandblasting and powder coating on the entire surface. The sparkling ocean blue powder coating will not only be beautiful and brilliant but safe to the touch. However, we would like to emphasize that the sculpture should not be climbed but touching will be welcomed.

#### Site

We feel that the site for installing the *Letters* would be most suitable by the library and by the drop-off area by the Live Oak Tree on the concrete pad as indicated on the landscape plan on the next page. The sculpture will be securely situated to ensure easy passage by pedestrians. We would also welcome recommendation by the selection committee regarding other potential locations for the *Letters*.


Sculpture Study of Letters rendered in the plaza by the architect team








Detail of *Letters* and the inspirational words on the ground which are also repeated in the main part of the figure
